Inside the store, convenience often comes down to flow. Is the check-in process quick and respectful? Are the menus readable? Does the room feel rushed or comfortable? FAQ About Cannabis Store Lyons

How much can a non-resident buy from a dispensary in Colorado?

Colorado residents 21 and older can purchase up to one (1) ounce marijuana from a licensed retailer. Non-residents can purchase up to 1/4-ounce at a time.

What is the highest mg edible you can buy in Colorado?

In Colorado, the maximum THC content you can buy in a single recreational edible package is 100 mg, with individual servings capped at 10 mg. However, registered medical marijuana patients can purchase up to 20,000 mg per transaction with a valid medical card.

Can you go to two dispensaries in one day in Colorado?

You can visit multiple dispensaries in a single day — but your purchase limit applies statewide, not per store. Colorado's cannabis tracking system (Metrc) monitors purchases across all licensed retailers.
