Other risks include: 1) No data protection - your PAN, Aadhaar, and bank details shared with unknown agents can be misused, 2) No responsible gaming tools - no deposit limits, self-exclusion, or age verification, 3) Addiction - fast live markets encourage impulsive chasing, 4) Money mule exposure - you may unknowingly route funds linked to larger illegal operations. Red flags to watch for: promises of guaranteed profit, fixed matches, doubling money, pressure to deposit urgently, bonuses that lock withdrawals, and requests for OTPs or screen sharing. Legitimate financial services never ask for these. If you have already shared funds with an unknown agent, stop further transfers, preserve chat and transaction records, inform your bank, and consider reporting to cybercrime.gov.in or 1930 in India.
