

If an electrical injury happened at work in Georgia, there is usually more than one responsible party.

A site has an owner, a general contractor, the electrical sub, sometimes a utility, sometimes an equipment manufacturer, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you [Additional info](#) from suing the employer directly. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, since comp covers none of the human loss and only part of the financial one.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which **atlanta personal injury attorney** an injured worker can obtain by asking.
