

When someone is shocked or burned on a job site in Atlanta, several companies may share responsibility.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the hazard.

The claim against the other company is normally where the meaningful money is, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Working out who was responsible [local truck accident lawyer](#) means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.
