

If you or your child were bitten around Atlanta, the rules may not be what you assume.

Some states hold the owner responsible no matter what. That is not the Georgia rule. The question is normally whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

Local ordinance violations are usually easier to establish, so the early questions focus on [lawyer for big rig accident](#) whether the animal was restrained and whether a complaint was ever filed.

Records disappear quickly here. Animal control files and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
