

If a dog bit you in the Atlanta area, the legal standard surprises most people.

In some places an owner is liable automatically. Georgia does not work that way. The claim generally turns on whether the owner knew the animal was dangerous, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

A **big rig accident lawyer** leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

This evidence does not last. Prior complaints and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
