

When a rider is hurt and were hit in Atlanta, the assumption is already working against you.

Adjusters and jurors bring an assumption to these cases: that the rider was speeding, was lane splitting or weaving, or took a risk a car driver would not.

Sometimes it fits. More often a driver looked and did not register a single headlight.

Reconstruction matters more here than testimony, since the story is doubted before it is told. Sight line analysis carry more weight than either version of events.

Severity helps and hurts. A rider has no structure around them, so identical forces cause much greater harm. Expect an argument that choosing to ride was itself the risk.
