

If you ride and were hit in Georgia, you are starting from behind.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, was weaving through traffic, or accepted a risk nobody else would.

Sometimes that is accurate. Usually the car turned left across a rider who had the right of way.
