

What Exactly Is an Anion Gap?

The **anion gap** is a calculated value used to assess **acid-base disorders** and general **electrolyte balance**. 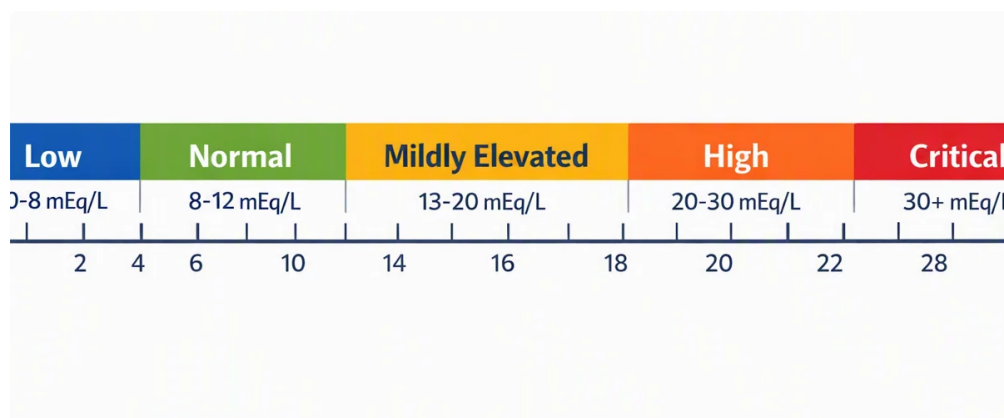
