

Getting hit by an 18-wheeler is not a bigger fender bender. A loaded tractor trailer can weigh many times what your car weighs, and the injuries are usually far worse.

The difference starts in the first hours. The trucking company often sends its own people to the scene the same day, before you are out of the hospital. They start protecting the company immediately.
