

A rideshare [Home page](#) wreck raises a question a normal car crash does not: whose insurance actually pays. The answer depends on what the driver was doing at that exact moment.

If the app is off, it is an ordinary car wreck, and only the personal policy is in play. When the app is on and they are waiting for a ride request, a smaller layer of coverage generally applies. #### **How much does a personal injury lawyer cost in Atlanta?**

## **What should I do after a truck accident in Atlanta?**

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
