

When a rider is hurt and a driver did not see you in Georgia, there is a prior you have to overcome.

These cases get built on physical evidence rather than narrative, because narrative starts at a disadvantage. Scene measurements carry more weight than either version of events.

Severity helps and hurts. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding **car wreck legal help** at all.
