

If a dog bit you around Atlanta, Georgia works differently than people expect.

In some places [personal injury wrongful death lawyer](#) an owner is liable automatically. Georgia is not one of them. Usually it comes down to whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. Owners rarely volunteer that a dog has snapped before, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

These records fade fast. Prior complaints and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.

#### **How much does a personal injury lawyer cost in Atlanta?**

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. ## **How long do I have to file an injury claim in Georgia?**

Georgia generally gives an injured person two years from the date of the injury to file a personal injury lawsuit, and a claim against a city, county or state agency can require written notice far sooner than that. Waiting also makes proof harder to collect, because records and camera footage do not last forever. Flanagan Law, P.C. reviews the deadlines that apply to a specific Atlanta case at no cost.

## **What should I do after a truck accident in Atlanta?**

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer. Trucking companies often send their own investigators to the scene within hours, and evidence such as onboard data and camera footage can be overwritten or lost in days.
