

Commercial metal roofing tends to earn trust for a reason. When it's installed correctly and kept up with inspections, it can handle wind-driven rain and a lot of day-to-day wear with a lot of dignity. After an event, post-event evaluation can identify cases where repair is preferable to full replacement, but it also can uncover structural distortion or broader system impacts. With metal roofing, that can mean problems aren't limited to one panel.
