

If you ride and were hit in Georgia, the assumption is already working against you.

Adjusters and jurors bring an assumption to these cases: that the rider was speeding, was weaving through traffic, or accepted a risk nobody else would.

Sometimes that is accurate. Usually the car turned left across a rider who had the **commercial truck accident Atlanta** right of way.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. The geometry of the turn do the arguing.

Severity helps and hurts. A rider has no structure around them, so identical forces cause much greater harm. The defense response is often to argue the rider accepted that risk by riding at all.
