

If you were hurt on a bus in Atlanta, the deadline may be far shorter than you think.

An ordinary Georgia injury claim generally allows two years to file. Where a government entity owns the bus, written notice may be due in months rather than years, and it has to be in the right form and go to the right place.

Missing that notice can end an otherwise strong case before it starts.

Who owns the bus drives the analysis. Injuries on a public transit bus, a school bus, a private charter and a hotel shuttle each run on different rules. It sets the deadline, the immunity analysis and the coverage available.

There is a second deadline nobody announces. Buses are heavily camerad, inside and out, and retention is often measured in days or weeks. A preservation letter [truck accident lawyer](#) sent late is a letter about footage that no longer exists.
