This verification gating step is critical: without knowing the exact fault location and its scope, we cannot accurately estimate whether a simple recovery-and-charge will hold or whether you'll face repeated failures.

Once the leak is confirmed, we cross-reference the repair cost against your appliance's age. A 3-year-old refrigerator [Informative post](#) with a minor evaporator leak might warrant a repair because the unit has many years ahead. A 12-year-old unit with the same leak moves toward the replacement threshold under the 50/50 rule. Recovery-and-charge is a core diagnostic technique we use to test whether a sealed system can be restored to function. During this step, we extract remaining refrigerant using EPA-certified recovery equipment, then pressure-test the empty system to confirm the leak is real and measure its size. If the leak is small enough that recharging will likely hold for another 2–3 years, and your appliance falls below the 50/50 threshold (younger and less expensive to fix than replace), recovery-and-charge is the right diagnostic outcome.

However, if the leak is extensive or the appliance is older and more costly to fix than replace, we skip or abbreviate the recovery-and-charge step in favor of recommending replacement. This diagnostic economy saves you money and prevents the regrettable scenario of paying for a recovery-and-charge on an appliance that fails
