

What Is the Anion Gap?

The **anion gap** is a derived measurement that assists clinicians evaluate the balance of ions in the blood. It is based on common **electrolytes** obtained on a chemistry panel, especially **sodium**, **chloride**, and **bicarbonate**. Because not all ions are directly measured, the anion gap reflects the amount of **unmeasured anions** in the bloodstream.

A simple **anion gap formula** is often used in blood chemistry:

Anion gap = sodium – (chloride + bicarbonate)

This result is helpful because it helps reveal **acid-base balance** and can help recognize an **acid-base disorder**, especially **metabolic acidosis**. When the gap is higher than expected, it may indicate acid retention or an increase in unmeasured acids. When it is lower than expected, it may be due to albumin changes, laboratory issues, or other causes.

Can Pregnancy Alter the Anion Gap?

The brief answer is: **pregnancy can affect the anion gap, but often only modestly**. The effect is usually indirect and associated with **pregnancy physiology** rather than a disease state. During **normal pregnancy**, several **physiologic changes** occur that can change the usual laboratory pattern.

One major change is expansion of **plasma volume**, which spreads out some blood components. Pregnancy also causes **respiratory alkalosis** because breathing tends to become slightly more fast and deep. This lowers carbon dioxide levels and can lead to adaptive changes in bicarbonate handling.

At the same time, the kidneys and other organs undergo **renal adaptation** to maintain maternal and fetal health. These adaptations influence electrolytes, protein concentrations, and acid-base status. As a result, the anion gap in pregnancy may not look exactly like it does outside of pregnancy.

That said, pregnancy does *not* automatically cause a dangerous anion gap abnormality. A somewhat changed value may still be normal for that physiologic state. The key is to interpret the result along with symptoms, the full electrolyte profile, and whether there is any evidence of **metabolic acidosis** or another acid-base issue.

The reason the Anion Gap Can Appear Different in Pregnancy

Various pregnancy-related factors can cause anion gap seem lower or somewhat different from a pre-pregnancy baseline. The main reason is a shift in **albumin**. Since albumin contributes to the pool of unmeasured anions, a lower albumin level can reduce the measured gap even when acid-base status is otherwise stable.

What Counts as a Usual Anion Gap in Pregnancy?

There is not one universal **reference range** that applies to every pregnant patient and each lab. Various labs use varying methods, and those methods change the reported values. In addition, **laboratory values** may vary depending on whether potassium is included in the calculation and whether the lab's method has been standardized to a particular analyzer.

In pregnancy, a result that is a bit lower than normal may still fit the expected pattern if albumin is reduced and the rest of the clinical picture is stable.
