

If a dog bit you in Georgia, the legal standard surprises most people.

Certain states impose liability regardless of the animal's history. Georgia is not one of them. The question is normally whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

The ordinance route is frequently more provable, so the early questions focus on whether the animal was restrained and whether anyone [big rig accident lawyer](#) contacted animal control.

Records disappear quickly here. Animal control files and recollections both fade, and the dog itself may be gone before anyone captures what it had done before.
