

When someone is shocked or burned on a job site in Georgia, several companies may share responsibility.

A site has an owner, the general contractor, the electrical subcontractor, sometimes a utility, sometimes an equipment <https://veloriftlabs.com/s/GqUWQ3RXNxphP6Q0AmbK5> manufacturer, and sometimes a labor supplier. Each carries its own coverage and its own reason to blame someone else.

If the injury happened at work, workers compensation covers medical treatment and part of your lost wages, and it prevents you from suing the employer directly. It does not bar a claim against a third party whose conduct created the **atlanta personal injury attorney** hazard.

That third party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.
