Adjusters and jurors bring an assumption to these cases: that the rider was speeding, was weaving through traffic, or accepted a risk nobody else would.

Sometimes it fits. Usually the car turned left across a rider who had the right of way.

Reconstruction matters more here than testimony, since the story is doubted before it is told. Damage patterns do the arguing.

Injury severity cuts both ways. A rider has no structure around them, so the same impact produces far worse injuries. Expect an argument that choosing to ride was itself the risk.
