

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer turns on what the app was doing when the crash happened.

If the app is off, it is an ordinary car wreck, and their personal policy applies. When the app is on and they are waiting for a **PI lawyer in Atlanta** ride request, a limited amount of coverage usually applies. Once they have accepted a ride or have a passenger in the car, a far larger commercial policy usually applies.

That timing is not a small detail. It can decide whether the coverage available is modest or substantial, and the app data that establishes it belongs to the rideshare company.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each one can reach different policies.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
