

A rideshare wreck raises a question a normal car crash does not: whose insurance actually pays. The answer depends on what the driver was doing at that exact moment.

If the app is off, it is an ordinary car wreck, and only the personal policy is in play. Once the app is on and the driver is waiting for a request, a limited amount of coverage usually applies. Once a ride is accepted or a passenger is aboard, a much larger commercial policy typically comes into play.

That timing is not a technicality. It can decide whether the coverage available is modest or substantial, and the records that prove it sit with the rideshare company, not with you.

It matters whether you were the passenger, the other driver, a pedestrian or a cyclist. Each position can reach a different layer of coverage.
