

What Is the Anion Gap?

This **anion gap** acts as a computed value that assists clinicians evaluate **acid-base balance** by comparing the major measured cations and anions in the blood. It is most often derived from routine **serum electrolytes**, especially **sodium**, **chloride**, and **bicarbonate**. Common Mistakes in Anion Gap Analysis
