

If a dog bit you in Atlanta, the rules may not be what you assume.

Some states hold the owner responsible no matter what. That is not the Georgia rule. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and neighbors are often reluctant **lawyer for big rig accident** to get involved.

Local ordinance violations are usually easier to establish, which is why the first questions are about where the dog was and whether anyone contacted animal control.

This evidence does not last. County records and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.
