The reason potassium is omitted is that its concentration is significantly lower than sodium, so including it usually affects the result only slightly. A normal gap does not rule out disease. Some forms of metabolic acidosis produce a normal anion gap, especially when bicarbonate loss is balanced by chloride increase. That is why the clinical interpretation must account for the full electrolyte pattern and not just the calculated number. The **chloride level** and **blood bicarbonate** values are especially relevant here.

In practice, the anion gap is best used as part of a broader assessment of **acid-base balance**, not as a single yes/no test.

An elevated anion gap often indicates that an acid load is present. Providers commonly think about **toxic alcohols**, **salicylates**, lactic acid, ketones, and retained acids from kidney dysfunction. The pattern can help guide urgent evaluation and treatment.

Toxic alcohols such as methanol and ethylene glycol are classic causes of a high gap. These substances are metabolized into acids that raise the gap and can produce severe toxicity. **Salicylates** can also alter acid-base status and may cause a mixed picture, sometimes including respiratory alkalosis alongside metabolic acidosis.

Uremia, which is associated with advanced kidney dysfunction, is another major cause. When the kidneys cannot clear acids efficiently, the gap rises. This is one reason the anion gap is a valuable clue in evaluating **renal failure** and other metabolic disorders.

Other causes include lactic acidosis and ketoacidosis, which are often recognized quickly because they fit the clinical setting. 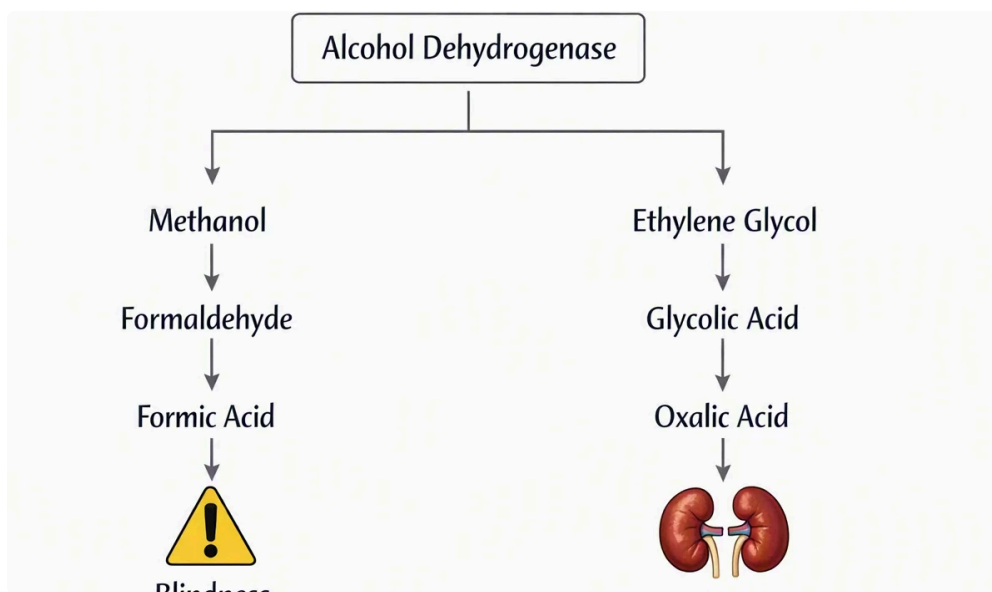
